You have this person associated with your law school. In case you didn't know (??) the group she leads, Texas "Humane" Legislation Network, is fund raising by false pretenses! I have been so stating at my site [www.texaspetprotect.org](http://www.texaspetprotect.org) since March 2019. Specifically, omission of major material fact! In 2011 her group succeeded in defeating a Texas bill which would have ended gassing of shelter pets. In 2013 THLN switched and supported a bill to

end gassing. At THLN site they only mention what they did in 2013. Meantime due to THLN's obstructionism, some 30,000 Texas shelter pets were avoidably sent to gas chambers. THLN misrepresents its lobby record to donors so as to wheedle donations. Where in law can you show us there is any right to mislead donors to collect funds???

#### Not Effective

THLN has had very minimal, if any, positive impact on animals in Texas. It has a very small staff, has accomplished little, and has a very negative reputation among Texas legislators. Its greatest claim to fame is its help in passing Texas's Puppy Mill bill this year, but in reality, the bill does little more than allowing puppy mills to register for state licensing, which could in fact backfire on any efforts to actually stop puppy mills by legitimizing their efforts. THLN also does not stand for what its supporters mistakenly believe it stands for. The organization this year lobbied against a bill that would have banned gas chambers at municipal shelters. The organization defended its position by saying that shelters should decide how they kill animals, not the legislature, and that shelters--- not the animals--- are the "primary stakeholders" when it comes to animal welfare in Texas.

When I complained to the State AG Office, I discovered that like the Austin BBB, THLN had **SUBORNED the AG Office** by means of THLN supported the AG's wife for State Legislature! The



at her THLN website at “Our Victories” that her group succeeded in defeating Texas House Bill 3450 in spring 2011; and as a consequence of that “success,” the ban on carbon monoxide gassing of Texas shelter pets was DELAYED by a full two years (24 months) OR 2) JETTISON Ms. Bobosky from participation in any form with Southern Methodist University School of Law.

We are prepared to take this matter to the Methodist Church governing council or other such entity in case you need to be prodded to do the right thing. THLN has demonstrated a pattern of “covering their ass” by influencing the BBB and the State AG Office; THLN has as a virtual Siamese twin the Dallas Young Lawyers Association; so we wonder, “did THLN achieve any undue influence in IRS Dallas?” Within two weeks after I complained to BBB about bias, Rick Bousquet was out of the Fort Worth/Austin BBB hierarchy and he scurried over to Amarillo where like a horsefly, he landed at Amarillo Botanic Gardens. Now as of mid October 2019, Laura Donahue Halloran, a more recent THLN exec dir, is suddenly gone, just after I contacted an official with

Albertson's Stores in Boise Idaho, as to THLN fundraising by offensive half truths!

This appears also to be a matter for review by the United States Postal Inspection Service regarding potential MAIL FRAUD, which is extremely SERIOUS! THLN has made the United States Mail an accessory to its fundraising by omission of major material fact!
